UPDATE ON CASA BALTIMORE'S ACTIVITIES

- Last year (July, 2005-June, 2006) CASA Baltimore's 106 volunteers served 203 abused and neglected children. **Currently CASA Baltimore's 100 active volunteers are serving 185 children.**
- CASA Baltimore was the **lead agency** in a collaborative project involving eight CASA programs in the Baltimore-Washington area that provided in-service training and pre-service training for CASA volunteers.
- CASA Baltimore currently employs **three full-time and one part-time professional staff** that provide training and supervision to CASA volunteers.
- CASA Baltimore honored **Joan Little, Esq.** as our **Child Advocate of the Year** at our annual luncheon in May, 2006. CASA Baltimore sends thanks to all our sponsors, friends and guests and to Joan Little for her amazing commitment to the children of Baltimore City.
